

SPECIFIC RULES FOR GOOD MORNING FOOTBALL: OVERTIME CAMPAIGN

In addition to the [General Rules](#) posted on the website for Station, which is owned and operated by the Company, the following Specific Rules apply to this Promotion. Please consult those General Rules in addition to these Specific Rules (collectively, the General Rules and these Specific Rules shall be collectively referred to as the "Official Rules"). All capitalized terms not defined in these Specific Rules will have the meanings established in the General Rules. In the event there is a discrepancy or inconsistency between those General Rules and these Specific Rules, these Specific Rules shall control.

PROMOTION DESCRIPTION:

Station:	WMMJ-FM which is owned and operated by Urban One, Inc. d/b/a Radio One Washington, DC
Promotion:	Good Morning Football: Overtime Campaign
Promotion Period:	The Promotion will run Monday November 17, 2025, through Friday November 21, 2025.
Limitation on Participation:	Participants must be eighteen (18) year old or older to participate in this Promotion. Anyone who has previously won a prize in another promotion of any kind from any one of the following radio stations in the previous thirty (30) days is not eligible to submit an Entry for this Promotion: WDCJ, WPRS, WKYS, WYCB, and WOL.
Entry Method:	The only way to submit an Entry for this Promotion is by calling the Station 202-432-1023 when prompted to do so during the 1:00 PM hour during each day of the Promotion Period. The Station will solicit phone calls by asking a daily trivia question. Caller #10 will have the chance to answer the trivia question, and if answered correctly, the Participant will become a Qualifying Winner. Each Qualifying Winner will be required to furnish a phone number to the Station for the Grand Prize Winner Selection. Any Qualifying Winner who is unwilling or unable to furnish a phone number and participate in the Phone Call (as described below) will forfeit the Qualifying Prize and not be eligible to be selected for the Grand Prize.
Number of Entries	Participants may call the Station as many times as they would like in an effort to become a Qualifying Winner. Participants may only become a Qualifying Winner once during the Promotion Period.
Number of Qualifying Winners:	There will be five (5) Qualifying Winners, one (1) for each day of the Promotion Period.
Qualifying Prize:	Each Qualifying Winner will receive one (1) \$100 NFL Shop Gift Card per day, with an approximate retail value ("ARV") of \$100.00
Grand Prize Winner Selection:	At the end of the Promotion Period, one (1) of the five (5) Qualifying Winners will be randomly selected by the Station to receive the Grand Prize. The Participant selected by the Station to be the Grand Prize Winner will be called at 2:00 PM on November 21, 2025, live on the air

to be notified of his/her selection as the Grand Prize Winner (“Phone Call”). If the first selection does not answer, a second selection will be called, and so forth. Any Participant who submits an Entry to this Promotion understands, acknowledges, and agrees that, if selected to be the Grand Prize Winner, that Participant’s name and voice will be broadcast by the Station.

Grand Prize: One (1) “Family Four Pack” consisting of four (4) tickets to the Washington Commanders home game on Sunday, November 30, 2025, (time to be determined) at Northwest Stadium, 1600 Ring Road, Landover, MD 20785 (“Venue”), with an ARV of \$1,500. The Grand Prize includes tickets only, and does not include any incidental expenses (such as ground transportation, parking, merchandise, concessions, or any other expenses) related to attendance of the game, which are the sole responsibility of the Grand Prize Winner.
